We believe in the full transparency of costs; therefore, we will not charge you hourly rates. Instead, you will be charged a fixed fee. We look to offer you the service that would help you the most.

There is a range of immigration applications that we advise and assist on. We have compiled a list of services that we provide to help you identify what is relevant for you.

Our Service and Fees

The firm is not yet VAT registered; a 20% VAT will be applied when VAT becomes operative. The VAT registration is pending, and the actual fee without VAT applies.

Our Service Includes:

If your case is covered by one of the following scenarios, you should obtain legal assistance at the very least:

- You're not sure if you meet the rules. The immigration rules in the United Kingdom are complicated to understand, and it is often unclear if a person satisfies the requirements for a certain route. If English is not your first language and you are finding it difficult to understand what's expected of you, we can help explain the process and requirements.
- If you have previously applied for a visa to the UK (or any other country) and been denied, or if you have previously overstayed a UK visa, we can assess your case and provide counsel. Similarly, if you have been arrested, have a criminal record (in any nation), or have a poor immigration background, you should seek immigration advice in the United Kingdom.
- The vast majority of UK visa applications, both from abroad and within the UK, are now completed online, requiring access to and completion of online forms as well as scanning of documents into digital format. We can assist you with your application.

If your situation or case is complicated, and needs a lot of documentation, or requires you to persuade UK Visas & Immigration about a specific fact or condition, we are able to help you.

Please see below an example of the services we offer and relevant fees.

Fixed Fees – Immigration Law

All fees are in GBP (VAT at 20% where applicable).

1. Work Visa, Company Sponsorship License, Sole Representative Visa Applications in the UK

Legal Fees: £1500 + VAT (£300) = £1800

This fixed fee covers the following stages:

- 1. Initial Consultation and Eligibility Assessment (1–2 days):**
We will review your circumstances, determine eligibility for the relevant visa, and advise on the best approach.
 - 2. Preparation of Application Documents (5–7 days):**
We will prepare all necessary documents for the application, including forms, evidence, and supporting documents.
 - 3. Submission to Home Office (On approval day):**
We will submit the completed application to the Home Office, ensuring all required documents are included.

Disbursements

In addition to the legal fees, there are several disbursements to consider, which vary depending on the type of visa and the applicant's situation. These include:

- 1. Home Office Fees:**
These fees are paid to the Home Office for processing the application. The amount can range from £719 to £1639 depending on the type of visa and the size of the sponsoring organization.

For example:

1. **Work Visa (Skilled Worker Visa):**
Generally £719 to £1,639 depending on the type of visa and length of stay.
 2. **Company Sponsorship License:**
Typically around £536 to £1,476, based on the size of the business.
 3. **Sole Representative Visa:**
Around £719 for a standard application.
 4. **Immigration Health Surcharge (IHS):**
This is a fee paid to access the National Health Service (NHS) during your stay in the UK. It is paid directly to the Home Office and is **£1,035 per year**, depending on the length of your visa.

2. UK Visa Entry Clearance Applications (e.g., Spouse Visa)

2. Immigration Health Surcharge (IHS)

This charge is paid directly to the Home Office to access NHS services in the UK and applies for the full duration of the visa.
